# **Lacey Shop Steward Report**

#### NEW MANAGEMENT=REPEATED ISSUES

#### Cell Phones:

If you don't want Management to call you on your cell phone, TELL THEM. If they do not listen, TELL ME. If your told you can't bring your cell phone to the street if you don't want Management to call you (as was done in another station), TELL ME. If you are retaliated on for Management not being able to manage using YOUR personal cell phone, TELL ME. Your cell phone should NOT manage the Postal Service.

Your responsibility with the use of cell phones is as follows: "The Dispute Resolution Team has RESOLVED this grievance. In accordance with Seattle District policies, personal cellular telephones are not prohibited but cell phone usage should not negatively impact or disrupt the productivity of the operation. Cell phones shall only be used when it is safe and reasonable to do so." This DRT decision was issued on January 28, 2005. Nothing has changed. Don't disrupt your work, be safe, be reasonable, AND don't be bullied into thinking you must use your phone in order for management to manage!

#### Driving on sidewalks:

You are bound by laws in accordance with the National Agreement, handbooks and manuals of the USPS. WAS 106-116-203; Specific parking prohibitions. (4) Parking and/or driving on sidewalks is prohibited.

Previous grievances have been filed and the Dispute Resolution Team has resolved that letter carriers will follow the laws and therefore, not drive on sidewalks.

Within the WAS there is no definition of a rolled sidewalk or a rolled curb. Do the right thing; don't park on a sidewalk and don't drive on a sidewalk.

#### Civilian clothes with case and go's:

President Floyd received a letter stating that beginning October 1, 2008 this Past Practice will be eliminated from the Lacey Post Office. I have already filed an Informal A grievance on the matter.

I really would like to see our Management work on some new, important issues. Route adjustments, Auxiliary Route 71 being made a full route, Route 53 adjusted appropriately into two routes, DPS issues taken care of and so on. As always though, work safe, work diligently and be proud of what you do! You are an awesome crew of Letter Carriers!
