Presidents Corner

Management at the Lacey Station has taken a stance of the Alternate Steward can not do union work unless the head Steward has the day off. Grievances have been filed trying to set this wrong straight again. Until then, while the head Steward is working on a Notice of Removal, I will be trying to help out. It also seems to me that management is stalling on granting Steward time in hopes that your Steward might forget a date and then they can claim a timeliness issue. Please help us out by reminding us of whatever is happening, so we don't forget.

ELECTION

I do not need to tell you how important it is to do something about the economy. I do not care what political party you back or support, but you must be thinking about what this Administration is doing for or to our country. When you go to the polls, please think about whom will represent and look out for the working class citizens of this country. A few statistics for you:

From 1947-1973: Household income increased 116% for the poor; 97% for the second class; 98% for the middle class; 103% for the fourth class; and 85% for the rich.

From 1973-2004: Household income increased 3% for the poor; 125% for the second class; 23% for the middle class; 38% for the fourth class; and 64% for the rich.

From 1979-2001: Household income for the top 0.1% increased 181%. This group averaged \$1.7 million a year.

From 1979-2001: Household income for the top 0.01% increased 497%. This group averaged \$6 million a year.

PRODUCTIVITY VS. WAGE GROWTH

From 1947-2004: Productivity increased 2 points while wages increased 1 point and then leveled out at 1 point. Productivity continues to rise while wages continue to stay the same.

GLOBALIZATION

The Mr. Coffee example:

Sunbeam buys Mr. Coffee and at it's factory in Ohio they paid their workers \$21.00 per hour in 1996. They moved the company to Mexico in 1998 and paid their employees \$2.36 per hour. Still wanting more profits they moved the company to China in 2001 and there they paid their employees a whopping \$0.47 per hour!

Article 8 of the JCAM states in part:

8.8. *C C*. The Employer will guarantee all employees at least four (4) hours work or pay on any day they are requested or scheduled to work in a post office or facility with 200 or more workyears of employment per year. All employees at other post offices and facilities will be guaranteed two (2) hours work or pay when requested or scheduled to work.

Part-Time Flexible Employee Call-In Guarantees Article 8.8.C, applies only to part-time flexible employees (see Arbitrator Mittenthal, H4N-NAC 21, September 11, 1987, C-07323).

• A part-time flexible employee requested or scheduled to work in a post office or facility with 200 or more workyears of employment is guaranteed four hours of work (or pay in lieu of work). If branch officers need to determine if their post office has 200 or more workyears of employment, they should contact their national business agent.

• A part-time flexible employee requested or scheduled to work in a post office or facility with fewer than 200 workyears of employment is guaranteed two hours of work (or pay in lieu of work).

• ELM 432.62 further provides that a part-time flexible employee who is called back to work on a day the employee has completed an assignment and clocked out is guaranteed four hours of work or pay regardless of the size of the office.

• National Arbitrator Britton held in H1N-3U-C-28621, December 13, 1988 (C-08530) that the two or four hour guarantee provided for in Article 8.8.C does not apply to PTF employees who are initially scheduled to work, but called at home and directed not to report to work prior to leaving for work.

**PTF's!! Take note of the last sentence! If you are NOT called at home PRIOR to leaving for work, your 4 hour guarantee applies!!
