OFFICIAL NOTICE

NOMINATION AND ELECTION OF OFFICERS AND DELEGATES BRANCH 351 OLYMPIA, WASHINGTON

This is an official notice to the membership of Branch 351 that nominations for the positions listed below and Delegates to the 2009 Washington State Association of Letter Carriers State Convention are open. The Branch President will be an automatic delegate to the State and National Conventions that will take place during the President's term of office.

Nominations for officers and convention delegates of Branch 351 will be held at the regular Branch meetings of October 2, 2008, and November 6, 2008, 7:00 PM, at 119 ½ Capitol Way N, Olympia, WA 98501.

All Branch 351 members are eligible for nomination, with the exception of those in supervisory positions or within two years following termination of supervisory status. Nominees must attend six of the twelve meetings before the convention to be eligible as expenses-paid Convention Delegates.

Nominations will be received from the floor or may be submitted in writing. Nominees must be present to accept or may indicate their acceptance in writing. Written nominations must be in the possession of the Recording Secretary no later than 8:00 PM, November 6, 2008.

The election will be conducted by secret mail ballot. The ballots will be mailed to all eligible members at least 20 days before the election. The election will be held on December 4, 2008. Ballots must be received no later than 7:00 PM, December 4, 2008. Write-in ballots will not be counted for any position, but will not cause the entire ballot to be invalidated.

<u>Unfinished Business</u>: JCAMs still haven't come out yet. Each branch will be receiving only one copy. JCAMs can be downloaded off the NALC website when available.

The official cells phones for the branch president and chief shop steward that were approved for up to \$125 a month came in at \$89 a month. A discussion followed concerning use of texting and the charges associated. Vincent Corsi will be checking the phone contract about texting.

There was nothing new on the status of the routes over at the Lacey office.

New Business: The subject of calendars was brought up and a long and emotional discussion took place. A motion was then made for the union to purchase calendars, seconded and carried.

A motion was made for all the delegates that go to conventions do After Action Reviews (AARs), seconded, discussed and failed.

Washington State workers that use the transit system are reimbursed. The Post Office doe not have a payback for transit riders. Good of the Association: NALC activist and Carrier Corp sign up forms were given out by Debbie Dixon.

No union money was spent on the Male Unbifurcated Garment Resolution. Dean Peterson was one of three paid delegates sent to the National Convention. Their per diem, airline tickets and lodging were the only things that were paid for. Dean estimates that he has spent close to \$3,500 out of his own pocket for his MUG resolution.

Chuck Merrilees is scheduled for triple-bypass surgery.

The Regional Convention will be here in Olympia, at the Red Lion Hotel, on the Westside, from 6-10 October. Sam Samuels, Debbie Dixon, Al Floyd, and Dean Peterson are the only one so far interested in going. Dean Peterson will be trying to schedule a bowling event for MDA, but it sounds like it could be difficult do to league bowling conflicts.

PTFs are being taken off of opts. Keep track of it, write it down, and give it to us.

If we are going to get bags for the food drive we need to start in November.

Some National Resolutions that were approved at the National Convention were the skort, skin cancer preventive clothing, and black and blue stockings for women.

Treasurer's Report: A motion was made to move \$116.21 to Donations and Gifts, \$262.84 to Education and \$387.75 to Telephone from the State Convention line item, seconded, discussed and carried. A motion was made to move \$50 from the State Convention line item to Donation and Gifts for a gift basket for Chuck Merrilees, seconded and approved. A motion was then made to accept the treasurer's report with the approved motion, seconded and carried.

<u>50/50 COLCPE Drawing:</u> The winning ticket was drawn by Dean Peterson. He won two kids Mariners Jerseys and \$2.50. He donated his \$2.50 to COLCPE for a total of \$5.

MDA Drawing: The winning ticket was drawn by Al Floyd. He won a NALC 66th Biennial Convention gift pack and \$10.50. He donated his \$10.50 to MDA for a total of \$21.

Presidents Report

There were a number of guest speakers that responded to the Unions invitation. The guests put an extra spark in the hearts of the delegates to feel that what we all are doing is making a difference as well as will make a difference in the lives of all union members and all letter carriers.

From the start it was up and roaring with President Young addressing all of us and telling us that we can rebuild this great country. We can take the lead in rebuilding the middle class through political action. Then we were able to hear Senator Hillary Clinton speak on how pleased she was to see such support for her. Everywhere she spoke. She said there was a welcome of letter carriers wearing those blue T-shirts. While in session the delegate voted on National Agreement Resolutions. Some that were disapproved by the Executive Council were job sharing, establishing an annual leave exchange option and the male unbifurcated garments. Ones approved by the Executive Council and thus approved by the delegates were Joint Statement Violators. Administrative leave for blood/organ donation, change regulations on the color of tights worn with postal uniforms and sun protective clothing. The delegates overturned the Executive Councils recommendation of disapproval and voted to approve the Skort.

I must say that the resolution for the MUG started with a lot of skeptic's, but after seeing how they actually looked and understanding that the wearing of the Kilt was a choice, more delegates minds went from disapproval to that of approval. Much respect and admiration to Mean Dean for introducing the resolution. Dean used allot of his time and especially HIS money to do he could to get what believed would be a benefit to all male letter carriers when comes to comfort while doing this job. Even in spit of the ignorance, closed mindedness, Neolithic thinking of this one delegate, (NBA, who has the Bay Area as within his region) Mean Dean kept his head up. Dean says he is going to try again at the next National Convention and I will do all I can to help in supporting him. I'm also going to help him with his other plan, a resolution that will give the Union the right not to represent those non-members, or to make those "scabs" have to pay a representation fee.
